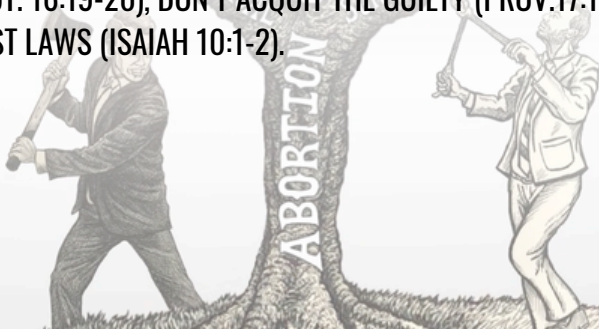

ABOLITION

- **Biblical** - Abortion is the murder of an Image Bearer of God. Everything we believe, say, or do to fight abortion must be based on God's word.
- **Gospel Centered** - Abortion is sin, the only solution for sin is the Gospel.
- **Church Driven** - The only institution entrusted with the Gospel is the Church of Jesus Christ. Abolition is the obligation of all Christians.
- **Providential** - We follow God's commands and trust in Him for the results. We are motivated by the second Great Commandment to love our neighbors as ourselves.
- **Immediate and Without Compromise** - We call for the total and immediate abolition of abortion without compromise. The laws against murder must apply equally to prenatal and born humans, with no exceptions.

PROLIFE

- **Avoids the Bible.** Uses politically correct language: abortion "ends a human life" or "stops a beating heart."
- **Man Centered.** Believes abortion should be made unthinkable through social programs, information campaigns, and incremental legislation.
- **Founded and led by secular and Christian individuals;** guided by pragmatism & the fear of man.
- **Abides by unlawful court opinions.** Writes laws that violate the U.S. Constitution by allowing the execution of prenatal children without due process of law.
- **Unjust.** Kansans for Life signed the 2022 National Right to Life open letter **OPPOSING** the complete criminalization of abortion. KFL wants some people exempt from prosecution.
